## Assisted Living Personal Service Plans

### **Traditional Care**

For residents who are primarily independent but may benefit from occasional cueing and reminders and who require little or no physical assistance with activities of daily living. An example would be a resident who needs reminders only with respect to one or more activities of daily living.

### Traditional Care I

For residents who are no longer fully independent but whose care needs consist primarily of more frequent cueing and reminders and who require little or no physical assistance with activities of daily living. An example would be a resident who needs reminders with respect to one or more activities of daily living, as well as with respect to mealtimes and activities.

### **Traditional Care II**

For residents whose care needs consist primarily of a moderate level of physical assistance with activities of daily living. An example would be a resident who needs some physical assistance with bathing, some aspects of grooming, dressing and continence management.

#### Traditional Care III

For residents who require a substantial amount of physical assistance with some activities of daily living due either to care needs or behaviors. Examples would be a resident requiring the assistance of two community associates for mobility and transfer or a resident requiring substantial or total physical assistance for dining, bathing and dressing, as well as moderate assistance with mobility, continence and grooming.

### **Traditional Care IV**

For residents who have extensive needs, such as a need for total care with one or several activities of daily living or a substantial amount of physical assistance warranted on a daily basis. Also, a resident using a mechanical or electric lift for transfers on an ongoing basis would be on Level IV at a minimum.

#### Traditional Care V

For residents who need total assistance with all aspects of care, including assistance with dining.

### **Medication Services**

### Mind & Memory Care Personal Service Plans

### Mind & Memory Care

For residents whose care needs consist primarily of cueing and reminders and who require little or no physical assistance with activities of daily living. Residents are appropriate for our plan if they generally exhibit mild cognitive impairment and no or limited behaviors that would require substantial increases in associate time, such as aggression or resistance to care.

### Mind & Memory Care I

For residents whose care needs consist primarily of a minimal level of physical assistance with activities of daily living and who generally exhibit a minimal level of cognitive impairment. These residents may also display one or more behaviors, such as aggression or resistance to care, that would call for additional associate time and attention.

### Mind & Memory Care II

For residents whose care needs require a moderate amount of physical assistance with several activities of daily living and who generally exhibit moderate cognitive impairment and/or associated behaviors.

### Mind & Memory Care III

For residents whose care needs require a substantial amount of physical assistance with several activities of daily living and who generally exhibit severe cognitive impairment and/or associated behaviors. Residents requiring the assistance of two community associates for transfers on an ongoing basis would be on Level III or higher.

### Mind & Memory Care IV

For residents who have extensive needs, such as a need for total care with one or more activities of daily living or a substantial amount of assistance warranted on a daily basis. A resident using a mechanical or electric lift on an ongoing basis for transfers would be on Level IV at a minimum.

### Mind & Memory Care V

For residents who need total assistance with all aspects of care, including assistance with dining. They may also require extensive emotional/behavioral support.
